## PROTECTED PLACES (NO. 9) ORDER 2015

### ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 5(1) of the Protected Areas and Protected Places Act, the Minister for Home Affairs makes the following Order:

#### **Citation and commencement**

1. This Order may be cited as the Protected Places (No. 9) Order 2015 and comes into operation on 3 December 2015.

#### **Premises declared to be protected place**

2.—(1) The premises described in the second column of the Schedule are declared to be a protected place for the purposes of the Act.

(2) No person may enter or remain in those premises unless the person —

- (a) is in possession of a pass-card or permit issued by the authority specified in the first column of the Schedule; or
- (b) has the permission of an authorised officer on duty at the premises to enter those premises.

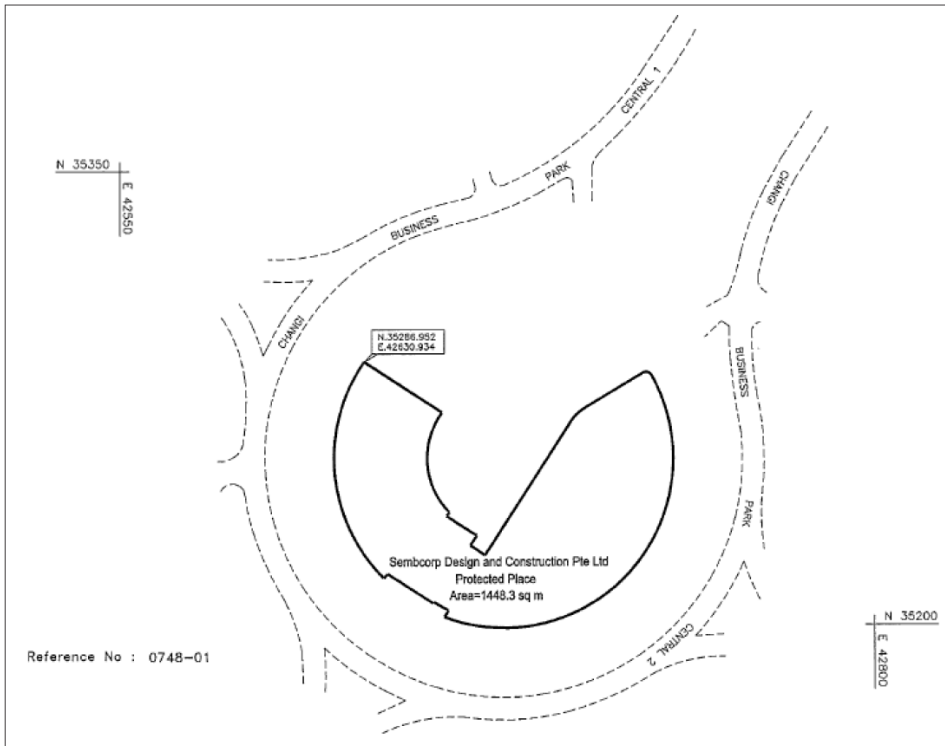
