1. These Regulations may be cited as the Sewerage and Drainage (Composition of Offences) Regulations.

Compoundable offences

2. The following offences may be compounded by the Board in accordance with section 70 of the Act:

- (a) any offence (other than a continuing offence) under section 10(5), 11(4)(a) or (b) punishable under subsection (4)(c), 13A(1), 14(4), 16(5), 16A(5)(a), 17(4), 18(1), 19(2), 20(1)(a) or (b) punishable under subsection (1)(c), 20(2)(a) punishable under subsection (2)(d), 22A(6), 22B(5), 24(4)(a) (in relation to a contravention of subsection (1)(a) or (1A)) punishable under subsection (4)(c), 24A(2), 26(5)(a) (in relation to a contravention of subsection (1A)) punishable under subsection (5)(d), 31(5), 33(7D) or (8B), 34(2), 35(2), 36(6), 38(3), 41(1)(a), 46 or 63(b) of the Act;
