##### Regulation

1. Citation and commencement

In exercise of the powers conferred by section 64 of the Telecommunications Act, the Info-communications Development Authority of Singapore, with the approval of the Minister for Information, Communications and the Arts, hereby makes the following Regulations:

##### **Citation and commencement**

1. These Regulations may be cited as the Telecommunications (Composition of Offences) Regulations 2005 and shall come into operation on 11th November 2005.

##### **Compoundable offences**

2. The following offences may be compounded by the Authority in accordance with section 64(1) of the Act:

- (a) any offence under section 21(7), 26(8), 29(6) or (9), 31(1), 32, 32E(3), 33(1), (3) or (4), 34(2), 35(1) or (3), 39, 40(1), 45, 46, 48, 49(1), (2) or (3), 52 or 59(6) of the Act;
- (b) any offence under the Telecommunications (Certificates of Competency for Ship Station Operators) Regulations (Rg 1);

- (c) any offence under the Telecommunications (Cable Detection Workers) Regulations (Rg 4);
- (d) any offence under the Telecommunications (Radio-communication) Regulations (Rg 5);
- (e) any offence under the Telecommunications (Dealers) Regulations (Rg 6);

- (f) any offence under the Telecommunications (Internal Wiring) Regulations 2005 (G.N. No. S 479/2005) as in force before 1 July 2024;
