In exercise of the powers conferred by section 24(1) of the Town Councils Act, the Town Council for the Town of East Coast-Fengshan makes the following By-laws:

##### **Citation and commencement**

1. These By-laws are the Town Council of East Coast-Fengshan (Conservancy and Service Charges) By-laws 2017\* and come into operation on 1 June 2017.

*[\*The Town of East Coast-Fengshan refers to the Town of East Coast according to the Town Councils (Declaration) Order 2020 (S 641/2020)]*

##### **Conservancy and service charges**

2. Every owner or tenant of —
- (a) every flat in any residential or commercial property; or
  - (b) every stall in any market or food centre,

of the Board within the Town of East Coast-Fengshan\* must pay to the Town Council on the first day of each month the appropriate conservancy and service charges set out in the Schedule.

*[\*The Town of East Coast-Fengshan refers to the Town of East Coast according to the Town Councils (Declaration) Order 2020 (S 641/2020)]*

## Revocation

3. The Town Council of East Coast (Conservancy and Service Charges) By-laws (By 74) are revoked.

10. Shop without living accommodation	\$2.30 per square metre of the area of the shop, subject to a minimum of \$74.50
11. Kiosk or shoplet	\$2.30 per square metre of the area of the kiosk or shoplet, subject to a minimum of \$74.50
12. Stall:	
(a) Cooked food stall with an area of less than or equal to 10 square metres	\$195
(b) Cooked food stall with an area of more than 10 square metres but less than or equal to 15 square metres	\$352
(c) Fruit, preserved and dried goods, fresh fish and seafood, meat or poultry stall	\$95.50 for every 10 square metres (or part of 10 square metres) of the area of the stall
(d) Vegetable, bean curd and noodle, egg, ground assorted spices or miscellaneous stall	\$60.50 for every 10 square metres (or part of 10 square metres) of the area of the stall
(e) Piece and sundry stall	\$112 for every 10 square metres (or part of 10 square metres) of the area of the stall
13. Premises for use as —	
(a) Neighbourhood Police Post	\$1.50 per square metre of the area of the premises
(b) polyclinic	\$2.30 per square metre of the area of the premises
(c) private child care centre or day care centre	\$2.30 per square metre of the area of the premises
(d) child care centre or day care centre operated by a non-profit organisation	\$0.46 per square metre of the area of the premises

<i>Type of property</i>	<i>Monthly conservancy and service charges</i>
(e) social service centre operated by a non-profit organisation	\$0.23 per square metre of the area of the premises
14. Other commercial property	\$2.30 per square metre of the area of the property, subject to a minimum of \$74.50

*Note:*

(1) The rates specified under the heading “*Normal rate*” for items 1 to 5 apply to a flat —

- (a) where none of the owners or tenants and none of the authorised occupiers of the flat are citizens of Singapore;
- (b) where any of the following persons has an interest in any residential property not owned by or vested in the Board, or in any industrial or commercial property (whether or not owned by or vested in the Board):
  - (i) any owner or essential occupier of the flat, if the flat is sold by the Board;
  - (ii) any tenant or authorised occupier of the flat, if the flat is let out by the Board;
- (c) that is owned by or let to any body corporate; or
- (d) that is vacant.

(2) The rates specified under the heading “*Reduced rate*” for items 1 to 5 apply to all other flats.

(3) In paragraph (1) —

“authorised occupier” has the same meaning as in section 2(1) of the Housing and Development Act (Cap. 129);

“essential occupier”, in relation to a flat sold by the Board, means any authorised occupier of the flat who, together with any lessee or other authorised occupier of the flat, will form the necessary family or social nucleus to qualify the lessee to purchase or to continue to own the flat;

“tenant” means any tenant of the Board with respect to an entire flat.
